Mayor: absent, Councillors: C Fadden, N Gate, J Moen to chair as Mayor for this meeting & T Sepers. Clerk-Treasurer: P W Giles, Rd Supt E Pearson Fire Chief S McNally. Visitors: Mary Withers appeared to notify council that there are plans to form an auxiliary for the fire fighter's; the intent is to raise funds for equipment etc that is not part of the base requirements for the fire department. The department will also participate in the Bergland Family Fun Day to do some public education. S McNally updated on training, 6 new pagers (\$430) coveralls were received, trained on the fire boat, a used truck has been purchased to replace the Bergland tanker, the water tank to be completed in Bergland fire hall and the water system at Morson fire hall to be repaired before winter, and dump attendant to establish an area for dumping hot ashes, this to stop fires from starting in the dump area. Nancy Miller from MBI requesting the tournament weekend be designated community festival days. The Rd Supt filed his report, he is obtaining a copy of safety requirements for the playground equipment, will try to fit into his budget another ½ load of magnesium, will replace flags, and have the ball infield worked up with spiked harrows and the contractor to cut roadsides through village of Bergland and Morson on 621. Council held a general discussion about complaints and ratepayer issues and the policy is that complaints are to be in writing. A policy on the use of the halls as to time limits for entry and exit of groups for a day or rental (i.e. when can they enter to decorate and bring in beverages, and clean out items after the event.). An inquiry as to a hockey pool being operated at a local business was mentioned, the matter was turned over to OPP and business owner was advised on the matter as it relates to lotteries.

SEPERS & FADDEN & CARRIED that Council support the attached resolution of the United Counties of Stormont, Dundas & Glengarry requesting the province to fully fund the Farmland and Managed Forest programs.

The Clerk-Treasurer's report was reviewed. Dump fees for Big Island were discussed and the Clerk to produce a report. ARB hearing is to be held July 17 for D Crampton 2004-2007 tax years. The cemetery draft rules have been circulated to the 2 funeral homes and a monument dealer for comments. Contractor for COMRIF culvert project is to be completed work by mid October.
