The Road Supt submitted his written monthly report for council and it was noted that the ½ ton has now been repainted, Phase 1 work on the waterfront park was completed, Councillor Sepers & the Rd Supt attended the property of A Olson as requested and did not find any ruts in the roadway however 3 weeks later Councillor Fadden attended the site and was able to observe the ruts. Weather permitting the ruts are to be repaired. The Clerk-Treasurer reviewed his report as well as a budget update. The report included AMBIS report for October, two insurance proposals, POA payment, changes to OMPF due to social cost upload, 2009 OMPF will be the same as 2007 less uploaded costs and we should receive our full phase in of the grant. The cemetery program has been received and Morson Cemetery information has been entered. City of Thunder Bay will administer collection of the Provincial Land Taxes. Draft copy of Tangible Capital Assets Policy was reviewed and council requested some modifications and changes. 2009 levy for the NWHU will remain at 2005 level of \$54.33 p/c. Councillor Sepers declared an interest as Council discussed a letter sent to council members from the Peterson's regarding their Order to Comply to obtain a building permit, from 1992. The CBO has provided a letter to their lawyer outlining a way for them to obtain a permit (provide proper drawings, an affidavit that the building was constructed to the drawings and allow for inspections of the property) and resolve the issue.
