MTA was requesting an increase in funding for 2009 and MBI requested support for a permanent shelter building in the Gov't Dock park area. Council will consider the requests as part of the budget process. Fire Chief updated on the department as well as a list of capital item requests for 2009. Council will consider these requests as part of the budget process. Council expressed its concern on the water tank being over budget, Fire Chief some items were added after the estimate including the epoxy coating on the inside to cut down on rust & different dump system. - RR LIBRARY #09-43 GATE & FADDEN & CARRIED that the Rainy River Public Library be advised that the Township of Lake of the Woods will contribute \$3500.00 in support for the year 2009.
- CBC #09-44 SEPERS & FADDEN & CARRIED that the Township of Lake of the Woods Council call on the CBC to cancel all planned staff and programming cuts at the Northwestern Ontario CBC station; AND THAT the jobs involved in the delivery of CBC local and regional programming be retained in Northwestern Ontario and across Canada; AND THAT with respect to the shortfall in funding for the Canadian Broadcasting Corporation (CBC) we endorse an increase of Federal funding for the CBC; AND THAT the Clerk-Treasurer communicate the resolution to the Prime Minister, the Minister of Canadian Heritage, the President of the CBC and our M.P. and M.P.P.;
- FESITVAL #09-45 GATE & MOEN & CARRIED that the following days be declared as "community festival days" for Morson Bass International, to be held on August 14 to 16, 2009.
- OTHER

 The Rd Supt updated Council on some projected costs for various road projects from the road patrol last fall.

 Further project information will be forthcoming and some of these costs were used for the infrastructure applications. He will be starting grading and patching operations. The skate board park equipment is to be put back into the rink for the summer. The Rd Supt to ensure the playground equipment is inspected and base area covered with sand. Also the cement in the rink to be cleaned from the water pools. Council discussed the temporary use by-law for the construction trailer at the Bergland Café and they will not be renewing the by-law

and want the trailer removed. The CBO is also to check properties that have recreation trailers set up permanently and issue instructions to remove them as they are not a permitted use. Council discussed the waterfront park and the Clerk-Treasurer is to arrange to have plans drawn up for 1 or 2 24 x 40 wood covered pavilions and a combination 4 stall washroom (with pit & no running water) and change room building as well as a couple fire pits. The Clerk-Treasurer is to check out our authority to require logging operators leaving a buffer zone along our municipal roads. The Mayor & the Clerk-Treasurer will attend a meeting with Rainy River to discuss a joint bylaw enforcement officer. The Clerk-Treasurer reviewed his report including an offer to Petersons on their property to have them give a full and complete release of the municipality in order to remove the old Order to Comply, no response has been received, Councillor Sepers declared a conflict on this matter as his spouse rents the facility, on the 4 infrastructure proposals that we submitted. MTO aggregate permit area on Windmill Rd has been approved. The Clerk-Treasurer is to check for Heritage funding for part of our BCF infrastructure project as well if there is funding available for renewal of our community destination signs. The Mayor reported on her frustration of being heard at the RRDSSAB, we continue to pay a high rate and have no services in the community. Her efforts to have the apportionment formula and budget reviewed have been unsuccessful. Notice of the passing of Atikokan Councillor Charles Vidal was received.
