OTHER

The Fire Chief updated Council on a proposed five year capital spending plan, there will be pumper training in RR and a 1st aid course coming up, work on the water storage in Bergland is to happen soon. The Road Supt and council reviewed their Oct 5th road patrol and various items identified. T & K Sharp to remove the silt retention fence for the culvert on the COMRIF Project on the Old Hwy. Dump hours being reduced on Oct 15 with Tuesday instead of Thursday opening in Morson. A priority for possible infrastructure funding would be rebuilding and surfacing Lakewood Dr. Concerns of Council included the use of camping trailers and hunting with the village areas and placement of deer stands in residential areas. A public meeting will be held to get input from the ratepayers on the issue. The Clerk-Treasurer is to notify D McCormick the land ambulance coordinator for RRDSSAB that it was not proper for the ambulance crew to ask our fire fighters to accompany the ambulance to Rainy River for help with a patient unloading. The Clerk-Treasurer reviewed his report as well as a budget update, including a 2nd retro assessment from the ROMA Reciprocal insurance was received in the amount of \$22403 and due in January 2009. Council reviewed the May to Aug AMBIS monthly reports and an AMBIS meeting is to be held Oct 21. The Clerk-Treasurer drafted property standards by-law for council consideration and Council wants a more simplified by-law. Councillor Moen presented pictures and examples of columbariums and the matter was referred to the Cemetery Committee for consideration. The Clerk-Treasurer is to reserve 3 rooms for RRDMA in Atikokan Jan 31 2009.
