Councillor Sepers reported on a successful pumpkin festival held last weekend in Bergland, he also reported on the various meetings held so far to find suitable housing in Rainy River for doctor locums. This is necessary to ensure we can find a new doctor and have housing for locums to relieve the doctors for vacation etc. The next meeting will be held on Oct 18 with a public meeting on Oct 20, total costs and sharing of those cost have not yet been firmed up, Councillor Gate will also represent the Township on the Committee. The Clerk-Treasurer's monthly report included a financial update, POA 2011 draft budget, notice of increase in OMERS contributions by 1%, a report on lame duck status, tire recycle revenues, a draft statistics report on the vote by mail process. Vote by mail ballots were mailed Sept 27th for the Oct 25th municipal election, we have two candidates for mayor and ten candidates for the four council seats.
