FIRE CHIEF #06-98

FADDEN & MOEN & CARRIED that Council, with regret, accept the resignation of Chris Pollard as Fire Chief, effective Sept 30, 2006.

OTHER

The Rd Supt submitted his report on the roads, tarring to be done this week, transmission in grader acting up, floating dock was installed at Gov't Dock and compliments have been received for improvements at the dock area, will consider spraying for cluster flies at Bergland hall and council chambers, there was a picnic table removed from the top of the skateboard equipment. The Clerk will write Big Grassy & Sabaskong FNs for permission to repair navigation light at entrance to Little Grassy River. Councillor Sepers reported on the Recreation committee, with walkathon raising \$684, and at the 2 pow wows \$2008 was raised. Upcoming events include turkey shoot Sept 30, in Nov on the 4th a variety show, craft show the 18 and lutefisk supper on the 25th. A letter was received from MNR advising that a review of the facilities at Turtle Portage is underway; Council would hold public meetings to discuss options at a latter date once the MNR has concluded its review. MTO response about trees along Hwy 621 was received; a small portion of the road has been worked on so far. MMAH responded to inquiry about expansion of a trailer park at Sportsman's Harbor and they suggest an Official Plan amendment would be necessary for the project. The Clerk will attend a discovery with our lawyers in Kapuskasing Oct 18 regarding the insurance reciprocal. The cemetery committee review of proposed rules & procedures is to be completed this month. Council will meet with Rainy River to discuss a recycle program. Council discussed the draft POA budget and wants the committee to consider a reserve for uncollectible fines. The Clerk provided a budget update. A pump test was completed on our new pumper. ARB hearing will be held in Rainy River on Oct 27, 2006 for 1 property assessment for the last 3 years.
