The Road Supt updated Council on road work; and his monthly report was reviewed. The contractor is starting work on the COMRIF project this week. The Mayor read a letter from AMCTO which acknowledged a 20 year award for Patrick W Giles Clerk-Treasurer in the AMCTO. Councillor Sepers requested that Council spend 20 minutes each monthly meeting to review the OP to gain an understanding of the document and be prepared for a public meeting to review the OP. Councillor Sepers also gave his priorities from the recent public meeting and requested the other members of Council to make a list of priorities so that Council could set up and work on their list of priorities. The Rec Committee would like to put benches and trees in the Bergland Playground and the Gov't Dock and beach areas. The committee is to provide Council with a design for consideration.
